**Contract for Dianne Tennyson and Eric Vincent's
Art Connects Art School**

This contract is between _____ (parent's full name), parent of _____ (child's name) and Dianne Tennyson and Eric Vincent. We agree that your child will be attending art classes for the fall semester of 2011, beginning August 25 and ending December 15 (please see schedule).

The cost of classes is \$25 per hour, with a semester total of \$400, except for the Wednesday Group B which is a total of \$350. ***Please include your \$100 deposit to hold a spot for your child.*** This deposit will count toward the total cost for the semester. Full payment may be made at the beginning of the semester or may be broken into one or two payments. If you decide to make **two payments**, the first one of **\$200 is due by the week of September 19, 2011** with the **balance due the week of October 3, 2011**. If you decide to make only **one payment**, the balance is **due September 26, 2011**. Please initial which payment you would like to do: _____ **two payments** of Sept. 19th and October 3rd, 2011 or _____ **one payment** of **\$300 due September 26th, 2011**, with the exception of Wednesdays class Group B which \$250.

THERE WILL BE NO EXCEPTIONS TO THE PAYMENT AGREEMENT.

WE AGREE THAT CHILDREN WILL NOT BE DROPPED OFF EARLY OR PICKED UP LATE. ERIC OR DIANNE ARE NOT RESPONSIBLE FOR CHILDREN OTHER THAN DURING DESIGNATED CLASS TIMES.

Eric's classes are Tuesdays, Thursdays, and Fridays while Dianne's classes are Mondays and Wednesdays, though occasionally Dianne may substitute for Eric and Eric may substitute for Dianne.

Students will be allowed to miss up to three hours per semester and will be allowed to make up the hours missed at no additional charge during the make up dates and times listed on the schedule.

There is no guarantee that your child will be admitted to The School of the Arts.
